To qualify for the Technology Fast 50, companies must have had operating revenues of at least \$50,000 in 2001 and \$5,000,000 in 2005, be headquartered in North America, and be a company that owns proprietary technology or intellectual property that contributes to a significant portion of the company's operating revenues.
